LEGISLATIVE TERMS

Act – a bill passed by the Legislature.

Amendment – any alteration made, or proposed to be made, in a bill, motion, or clause thereof, by adding, changing, substituting or omitting.

Assembly – the lower house of the California Legislature, consisting of 80 members, elected from districts apportioned on the basis of population, who serve two-year terms, with a limit of three terms.

Caucus – an informal meeting of a group of the members, sometimes called on the basis of party affiliation. Also, the research staff and offices of the minority and majority leaders. Derived from an Algonquian Indian word.

Chaptered – after a bill is signed into law by the Governor, the Secretary of State assigns the bill a chapter number, which is subsequently used to refer to the measure rather than the bill number.

Constitutional amendment – a resolution affecting the Constitution adopted by the Legislature or presented by initiative, requiring an affirmative vote of the electorate to become effective.

Initiative – method of direct legislation by a vote of the people.

Senate – the upper house of the California Legislature, consisting of 40 members elected from districts apportioned on the basis of population, one-half of whom are elected or re-elected every two years for four-year terms, with a limit of two terms.

Session – period during which the Legislature meets: Regular - the biennial session at which all classes of legislation may be considered; Extraordinary - special session, called by, and limited to matters specified by the Governor.

Daily – each day's meeting; Joint - meeting of the two houses together.

Statutes – compilation of all enacted bills, chaptered by the Secretary of State in the order in which they became law, and prepared in book form by the State Printer.

Urgency/Urgency Clause – a matter affecting the public peace, health, or safety (see Art. IV, Sec. 8 (d), California Constitution). A bill that contains an urgency clause takes effect upon the Governor's signature. A vote on the urgency clause must precede a vote on the bill and requires a 2/3 vote for passage.

Veto – action of a Governor in disapproval of a measure. May be overridden. Item veto - Governor may reduce or eliminate items of appropriation while approving rest of bill. May be overridden. Pocket veto - Governor fails to sign bill after final adjournment. Cannot be overridden. A pocket veto is no longer possible under California Constitution.
